### Formation of Institutional Pharmacovigilance Committee:

#### Preamble:

Pharmacovigilance is the science dedicated to reduce the risk of drugrelated harms to patients. In India, National Pharmacovigilance Program under the control of Central Drug Standards Control Organization (CDSCO) has initiated Pharmacovigilance during 2003. WHO emphasizes that, traditional medicines are to be included into pharmacovigilance system and has published guidelines on safety monitoring of herbal medicines in pharmacovigilance systems in 2004. The nationwide program under central sector scheme funded by Ministry of AYUSH, New Delhi for ASU & amp; H drugs to establish and manage a data base of Adverse Drug Reactions (ADR) for developing system wise database of adverse drug reactions and evolving evidence based recommendations towards clinical safety of ASU & H Drugs. So, AYUSH systems have also been involved in this program with an objective of collecting, collating and analyzing data to establish evidences for clinical safety of Ayurveda, Siddha, Unani and Homeopathic (ASU and H) drugs in scientific manner for documenting clinical evidences of safety and to undertake surveillance of misleading advertisements of ASU and H for regulatory actions.

The Ministry of AYUSH has introduced new Central Sector scheme for promoting pharmacovigilance of Ayurveda, Siddha, Unani and Homoeopathy (ASU & H) Drugs. Prime objective of the scheme is to develop

the culture of documenting adverse effects and undertake safety monitoring of Ayurveda, Siddha, Unani and Homoeopathy drugs and surveillance of misleading advertisements appearing in the print and electronic media. The Standing Finance Committee (SFC) chaired by Secretary (AYUSH) approved the scheme on November 1, 2017 and subsequently it was rolled out for implementation in the country near the end of financial year 2017-18.

To scale up The Adverse Drug Reaction (ADR) reporting culture among healthcare professionals, Indian Pharmacopeia Commission, has requested to all NABH accredited Hospitals/organizations to get enrolled under PvPI as ADR monitoring Centre (AMC).

Considering importance of reporting ADRs, S.M.BT. Ayurved College and Hospital. Dhamangaon has established Institutional Pharmacovigilance Committee (IPC) on 1 February 2021
